The following is a Bill Of Materials for the build out of the multi-purpose room at Purcellville. As with all building projects it is an estimate and will doubtless change as the project progresses. I did pick up two new windows yesterday morning for just \$200. The woman has four more that she is willing to sell for \$350. I could easily incorporate them into the design but I wasn't will to go out on a limb without board approval. The prices shown below are off Home Depot's website and are full retail.

In addition to the above supplies we will need to provide Electrical supplies for all the internal wiring in the building. This can easily amount to \$3000 or more but Beckstrom has agreed to help out with whatever supplies they have in their warehouse, things such as conduit, wire, boxes, receptacles, switches, plates, etc. We also have some supplies already so this is a hard amount to estimate. My recommendation is to budget \$2000 and hope for even more generous donations.

This investment will get the building presentable and will get many of the tools (but not all) wired and operating. We will still need to deal with HVAC and new siding for the building.
